Course Snapshot

Duration

This course will be approximately 6-14 months in duration depending on the schedule selected, prior experience, Credit Transfers and individual needs of the learners.

Delivery Mode

This course is delivered via a combination of;

- » Either 1 or 2 days virtual face-to-face training sessions per week, depending on your schedule
- » We have multiple schedules available to suit you, including day classes (9.30am - 2.30pm) and night classes (6.00pm - 9.00pm)
- » 16 hours per week of self-paced flexible learning including completion of assignments
- » 1:1 coaching to provide all the support you need
- » 120 hours of mandatory practical placement

Entry Requirements

There are no pre-requisites to gain entry into CHC43415 Certificate IV in Leisure and Health, however you must;

- » Be over 15 years of age
- » Obtain a police check/certificate prior to practical placement
- » Willing and physically able to do practical placement
- » Undertake a Language, Literacy and Numeracy (LLN) assessment so that the appropriate support can be provided and or sourced
- » Undertake a Pre-Training Review (PTR) to provide us with an indication of your existing skills and experience
- » This course is virtual so you must have access to the internet, a computer and basic computer literacy
- » Have the ability to work autonomously and a commitment to attend virtual sessions.

More on practical placement

Practical placement is an important part of your course - 120 hours of practical placement is required to achieve your qualification. It is a great opportunity to put all your knowledge into action and showcase your skills to a prospective employer.

We arrange placement for you! We always aim to organise placement for you in a workplace that is aligned with your individual needs and aspirations, and if possible conveniently located.

When students are undertaking placement they must wear a student uniform at all times. You will be required to dress in the attire as directed by the facility where you complete practical placement.

We provide all learners with an Aged Care Training Services polo shirt and name badge. Any requirements over and above this (such as pants and shoes), you will be required to organise yourself and is not provided to you by ACTS.

COVID

Please note that practical placement is a mandatory component of the course completion and may be impacted by COVID or other infectious outbreaks. Rest assured we will inform you of any changes to your placement and work with you to complete your mandatory placement.

NDIS Check

Some workplaces such as Disability Services require students to have an NDIS check to commence placement. In this case, we will assist the student to complete an NDIS check and all fees associated with the check will be paid for by the student.

01	CHCCOM002 Use communication to build relationships This unit describes the skills and knowledge required to apply communication techniques to establish, build and maintain relationships with clients, colleagues and others.
02	CHCLAH005 Incorporate lifespan development and sociological concepts into leisure and health programming This unit describes the skills and knowledge required to understand how human behaviour across the lifespan development stages, and sociological concepts of health and leisure impact on leisure and health programming and client participation.
03	CHCPRP003 Reflect on and improve own professional practice This unit describes the skills and knowledge required to evaluate and enhance your own practice through reflection and ongoing professional development.
04	CHCLAH001 Work effectively in the leisure and health industries This unit describes the skills and knowledge required to work in a leisure and health context work and to effectively support a client's well-being.
05	CHCLAH002 Contribute to leisure and health programming This unit describes the skills and knowledge required to contribute to the creation, planning, coordination, delivery and evaluation of leisure and health activities.

08	CHCDIV001 Work with diverse people This unit describes the skills and knowledge required to work respectfully with people from diverse social and cultural groups.
09	HLTAAP002 Confirm physical health status This unit describes the skills and knowledge required to obtain client health information and check a client's physical health status.

10	HLTWHS002 Follow safe work practices for direct client care This unit describes the skills and knowledge required to follow safe work practice including work health and safety and infection control.
11	CHCPAL001 Deliver care services using a palliative approach This unit describes the skills and knowledge required to care for people with life-threatening or life-limiting illness and/or normal ageing process within a palliative approach. This unit applies to workers in a residential or community context.
12	CHCDIS001 Contribute to ongoing skills development using a strengths-based approach This unit describes the skills and knowledge required to assist with supporting the ongoing skill development of a person with disability. It involves following and contributing to an established individual plan and using a positive, strengths-based approach.
13	CHCDIS002 Follow established person-centred behaviour supports This unit describes the skills and knowledge required to implement behaviour support strategies outlined in an individualised behaviour support plan for a person with disability.
14	CHCDIS012 Support community participation and social inclusion This unit describes the skills and knowledge required to assist with supporting people with disability in community participation and social inclusion using a person-centred approach.
15	CHCMHS001 Work with people with mental health issues This unit describes the skills and knowledge required to establish relationships, clarify needs, and then work collaboratively with people who are living with mental health issues.
16	CHCVOL003 Recruit, induct and support volunteers This unit describes the skills and knowledge required to recruit, orientate, develop and support volunteer workers in an agency, service or program.
17	BSBPEF502 Develop and use emotional intelligence This unit covers the development and use of emotional intelligence to increase self-awareness, self-management, social awareness and relationship management in the context of the workplace.
